Graduation assessment tool

- Can be used at any time to gauge progress of the child and family progress toward graduation
- Should be kept in the case file

### Graduation assessment tool

- Caseworker completes the graduation assessment in consultation with a primary caregiver and also asks questions directly of adolescents in the household
- Caseworker then discusses results of the graduation assessment with immediate supervisor and determines with supervisor if all members of the household are ready for graduation
- Caseworker notes the graduation decision in the file along with actions needed if household is not ready to graduate

### Assessment tool for OVC programs

For each benchmark, the caseworker answers questions based on the case file, or by asking questions of a member of the household as stated in the tool.

All questions have Yes/No responses.

# Graduation data quality and

### sustainability assessment

The objective of the Data Quality and Sustainability Assessment (DQSA) is to assess performance of OVC projects and support project improvement.

The DQSA assesses three questions:

**Question 1**: Is the community-based organization (CBO) routinely and accurately employing the graduation benchmarks to gauge the progress of children and families?

**Question 2**: Are data on the number of those graduating accurately collected and transmitted centrally?

**Question 3**: Do graduated households continue to meet the graduation criteria 6–12 months after graduation from the OVC project?

# Graduation data quality and

### sustainability assessment

**Question 1**: Is the community-based organization (CBO) routinely and accurately employing the graduation benchmarks to gauge the progress of children and families?

### Methods:

- <u>Qualitative interviews</u> with monitoring and evaluation (M&E) officer, project staff
- <u>Review of case files</u>
- <u>Graduation verification assessment</u>: A sample of households is re-assessed against the graduation benchmarks,\* and the "match" between the two assessments is evaluated

# Graduation data quality and sustainability assessment

**Question 2**: Are data on the number of those graduating accurately collected and transmitted centrally?

### Methods:

- <u>Cross-checks</u> of data sources: Forward and reverse cross-checks of a sample of households
- <u>Recount</u> of graduated households using primary source documents and comparison with counts in DATIM

# Graduation data quality and sustainability assessment

**Question 3**: Do graduated households continue to meet the graduation criteria 6–12 months after graduation from the OVC project?

#### Method:

 <u>Sustainability assessment</u> of households: A sample of graduated households is re-assessed against the graduation criteria 6–12 months after graduation
